# County Council News.....

• On August 31, County Councilmembers held a **special budget workshop** and discussed the delivery of American Rescue Plan Act (ARPA) funds.

By a 4-2 vote, Councilmembers reduced their proposed general fund by \$2.8 million (3.8%). These reductions included beaches, environmental management, economic development, Marine Science Center, parks, land management. See budget sheet attached.

- The **County's Affordable Housing Webinar** which was to take place August 27 has been rescheduled to the Fall.
- County Council approves changes to ECHO program. These changes include increasing the Standard grants \$400,000 to \$600,000; exceptional grants increased from \$1.8 million to \$2.5 million and maximum grants increased to \$3.1 million. ECHO funds (vs County General funds) will pay for the two designated staff members.....other changes included match requirements making it easier for small nonprofits to participate. # City Commission/Council news.....

At their August 18 meeting, Daytona Beach City Commissioners approved the receipt of \$7.5 million in federal COVID-19 relief funds. Their plan is to use the money develop vaccine distribution sites as well as helping local businesses.

This plan was based on recent public meetings input and money will be applied to

Affordable Housing, Outdoor Art, Reading/Math Literacy, Small Business Recovery and Rehabilitation Grants and Landscape Grant Program.

The plan allocated \$350,000 for the Mayor while each commissioner will receive \$250,000 for their zone.

The remaining \$4.2 million will go toward developing and rehabilitating affordable housing, addressing educational disparities, and creating a small business equity, diversity and inclusion resource center.

# **County Council confirms new EMS director**

On August 3, the County Council confirmed **Michael Colman** as the new emergency medical services (EMS) director.

He brings 29 years of EMS and public safety experience as he replaces former EMS Director Jason Brady, who took a position in Newark, NJ. In collaboration with area hospitals and city fire departments, EMS provides pre-hospital 911 medical care and transportation in the county – averaging in excess of 60,000 transports per year.



County Manager George Recktenwald noted that Colman's experience

in special event management and a nurse triage program integrated into dispatch operations.

Colman was previously with the Richmond Ambulance Authority since 2018. Prior to that, he worked with the Atlanta-based Grady Health System

He has a bachelor's degree in applied science from Clayton State University and a master's degree in public administration from Columbus State University.

# Local Officials to Sharpen their Budget Pencils....


With the new fiscal year starting October 1, look for city and county government to conduct FY 2021-2022 budget workshops over the next several months.... see schedules below....
