Beachfront Recovery Construction Projects to continue during Volusia Seaturtle Nesting Season

The sea turtle nesting season began May 1st so turtles will be emerging from the surf to lay eggs on the beach in the next few months. Only about one in 1000 to 10,000 hatchlings make it to maturity which may take 25 years.

County staff wants to make the beaches a safe and inviting place for sea turtles AND humans. They also want beaches “clean, dark and flat” and residents are requested to turn off lights when not in use and to redirect lights away from the beach.

Construction projects are being coordinated by the County's environmental/coastal division, Dept of Environmental Protection and Fla Fish/Wildlife Commission.

May 1, Gov DeSantis signed 3 bills to strengthen "law and order" in Fla

Attorney General Ashley Moody joined the Governor and Brevard Sheriff Wayne Ivey in Titusville said Fla would reject “soft on crime policies” seen in other states.

Bills he signed....**Capital Sexual Battery HB 1297....harsher punishments for those trafficking fentanyl HB 1359 and Pretrial Release and Detention HB 1627.**



Legislative Session Adjourns.....

The legislature ended its Session last Friday after approving a \$117 billion which included

- a 5% raise for state workers
- permanent sales tax exemption many necessities reduction in communication services tax
- lower business rental tax

along with funding increases for education and the environment.

New budget starts July 1....\$5 billion higher than last year.....thanks to increased revenues.

Includes \$2.7 billion in tax cuts for consumers and businesses including

- toll road reductions,
- workforce housing tax relief for developers
- exemptions for hurricane repairs.

DeSantis has 15 days from the date he received the budget to sign it or exercise line item vetoes

Other notable bills sent to the Governor include.....

HB 1 Education allows any student a voucher to attend another school of their choice

HB 543 Constitutional carry for fire-arms...

enhances right to self-defense by allowing law-abiding 21-year old adults, legally eligible to obtain a permit and carry a handgun without govt permission; ensures right to self-defense without red tape.....

HB 837 Civil Remedies which determines reasonable attorney fee in most civil actions and reduces the statute of limitations for negligence actions; provides standards for bad faith actions

SB 246 Fla KidCare Eligibility which increases income eligibility threshold for coverage under Florida Kidcare program

HB 7063 Communications Services Tax sets state's CST at 6% rate (a 1.44 % reduction from its current level); prevents local govts from increasing their local CST rate for next 3 years;

SB 264 prohibits foreign principals connected with People's Republic of China, Chinese Communist Party, related entities from purchasing agricultural land & designated real property in Fla..

SB 102 Housing provides incentives for investments to build affordable housing; encourages mixed-use developments in commercial areas.....

SB 1718 Immigration steps up requirements for businesses to check immigration status of workers; cracks down on anyone bringing undocumented immigrants into Fla.

HB 1373 - Law Enforcement Operations specifies that a sheriff has exclusive policing jurisdiction in unincorporated areas; stipulates that their jurisdiction covers entire county regardless of incorporated cities or other independent districts or governmental entities in the county; prohibits county council from maintaining/establishing a separate policing entity in unincorporated areas i.e. Sheriff's Dept now covers Volusia's beaches

Gov DeSantis Awards \$100 Million to Impacted Coastal Communities Through Hurricane Stormwater and Wastewater Assistance Grant Program

During their December 2022 special session, the Legislature approved a \$100 million Hurricane Stormwater/Wastewater Assistance Grant Program to help impacted local governments address damages to stormwater/wastewater infrastructure due to Hurricane Ian or Hurricane Nicole.

Governor and **Fla Dept of Environmental Protection (DEP) Secretary Shawn Hamilton** awarded \$100 million to 16 counties (including Volusia) to repair damage to their stormwater/wastewater systems caused by Hurricanes Ian or Nicole.

Of this amount, **Daytona Beach was awarded \$3.9 million for storm water and waste water projects.**

Daytona Beach Hurricane Recovery Grant Funds are available for Residents and Businesses

Redevelopment/Neighborhood Services Dept staff are contacting hardest hit neighborhoods to inform them of grant availability.

Application deadline is July 31. Grants will be awarded on a first qualified/first serve basis. For more info, visit www.codb.us/recoverygrants

Last week, **Deltona City Commission** continued work on a proposed Deltona Village Business Planned Unit Development (BPUD) which will include numerous commercial structures. They were to address an amendment to increase multi-family units from 414 to 652 units AND rezone an additional 26.57 acres within the project.



However, **Commissioner Dana McCool** asked postpone the matter 60 days because the School Board is still clearing concurrency.

April 18— **Port Orange Councilmembers** unanimously approved an agreement with the International Union of Police Associations (IUPA) to raise all police officer salaries by \$1.95 per hour.



This brings the starting pay for an officer to \$24.00. It also includes an option to offer a \$5,000 bonus to anyone moving from another state to work for the Port Orange Police with at least three years of law enforcement experience.

The League will also honor **Daytona Beach Planning Director Dennis Mrozak** as their Employee of the Year in the Community, Planning and Development Category. Having been with the City for 14 years, he was nominated by **City Manager Deric Feacher**.

DB Shores' Nancy Maddox will receive a Economic Development Director of the Year.

Both will receive their Awards at the League's May 25 Meeting at the Brannon Center in New Smyrna Beach.

With **Daytona Beach's increased populations growth** on the west side of the city, all six of Daytona's zones will need to be adjusted to make sure each commissioner represents an equal number of residents.



Zones must be compact and equal the distribution of population. The goal of the reapportionment is to have close to 11 to 12,000 residents in each of their six zones.

2020 US Census count for Daytona Beach was 71,559 residents.



County Council Deliberates 2023 Goals

May 10 - Councilmembers worked to find consensus on what objectives they'd like the County to pursue this year.

Some of the recommendations included....

- Streamline the permitting process for small business
- More attainable housing
- Less regulations on the beach
- Revamp regulations and reduce red tape.
- Pursue low impact development
- Budget for SunRail

Brightline, at 130 mph is the fastest train in the Southeast....serving Miami, Ft Lauderdale, Boca Raton, W Palm Beach, and hopes to

open an Orlando International Airport station before July.

Orlando Mayor Buddy Dyer wants to see Brightline's Orlando station connect with the SunRail which operates between DeBary and Poinciana in Osceola County. Mayor Dyer said Orlando is applying for federal funding for that Brightline connection.

Meanwhile, work on DeLand's \$50 million SunRail station is already underway and should be complete by June, 2024.. It will be located on New York Ave just west of downtown.

May 8 Volusia Elected Officials Roundtable Mtg

Govt Affairs Liaison John Booker gave a recap of the recent legislative session.....**Coastal Division Director Jessica Fentress** “staff is working to open more dune walkovers and beach ramps... more than 1 million cubic yards of sand/trap bag to be placed along the coast over the next 2 years.....for property owners that agree to provide easement.

Staff working with Dept of Environmental Protection and Fish/Wildlife Commission to allow oceanfront construction to continue during the turtle nesting season.

Volusia Emergency Management Director Jim Judge “with the forming El Nino and other factors, this could help break up storms from forming or keep them off the coast i.e. a favorable forecast BUT we have to wait for Natl Hurricane Center’s forecast later this month as well as

Volusia School District and Volusia United Educators (VUE) signed an agreement to increase the pay that teachers receive for all tutoring offered before, during and after school to \$35 an hour. The previous rate for tutoring offered before and after school was \$30 an hour.

Supt Carmen Balgobin stated “the District is glad to work with VUE to increase compensation for teachers for these vital services.” This change begins with the 2023-24 school year.



At the same time, Volusia United Educators and the School District appear to disagree regarding a recent decision to cancel the Plus-One program this fall. Plus-One offers an extra half an hour of daily instruction for some 2000 designated students at Turie T. Small, Palm Terrace, West Side, Starke and Holly Hill K-8 School.



The District stated that the \$2 million state funded program was eliminated by the Fla Dept of Education. Stay tuned.....

May 9— Holly Hill City Commission held an economic development workshop. Much of the discussion focused on how to spruce up many of the hotels on US 1 and how to build upon the success of Pictona.

Gov DeSantis addresses Lloyds of London

On a recent trip to London, **Gov DeSantis** along with **Citizens Property Insurance Corp President Tim Cerio** provided an update on Fla’s efforts to stabilize the property insurance market and secured a commitment from re-insurance companies to increase access for carriers serving Fla policyholders.

He highlighted recent legislative reforms to promote competition/consumer choice to make the market more attractive to businesses.

He stressed importance of partnerships in supporting Fla’s large insurance-related economic sector, which includes over 4,800 businesses, writing over \$209 billion premiums. Fla’s insurance industry provides 213,000 jobs and is 3.5% of Fla’s GDP in 2020.

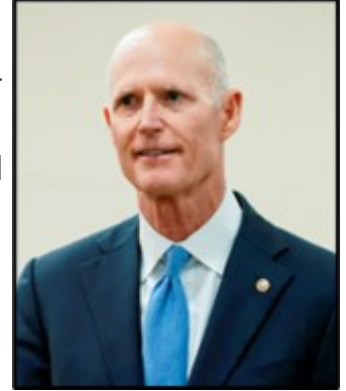
Let’s all hope that Fla gets more insurance carriers here to write new business....

Legislation Introduced to Tighten Bank Supervision.....Senators Rick Scott and Elizabeth Warren introduced legislation to replace Federal Reserve's internal watchdog with one appointed by President, aiming to tighten bank supervision following failures of Silicon Valley Bank and Signature Bank.

They blamed the collapse of those two banks on regulatory failures at the US central bank, which has operated up to now with an internal inspector general who reports to the Fed board.

Both Republicans and Democrats have pledged tighter oversight of banking regulators following the collapses of Silicon Valley Bank and Signature Bank, which were followed by billions of dollars in losses for financial stocks.

House Financial Services Committee is working on similar legislation.



The cooperation between Senators Scott and Warren could be the start of a new bipartisan push on banking.

April 28— by a 218-217, the US House approved its Limit, Save, Grow Act which would cut spending by \$4.7 trillion over a 10-year window.

- stricter work requirements for Food Stamps
- raise the gov't's borrowing limit until next year
- 13% cut in discretionary spending

Biden and Democrats want to raise the debt ceiling without any conditions.



May 9 **President Biden, House Speaker Kevin McCarthy, Senate leaders Chuck Schumer Mitch McConnell** met but failed to resolve the impending [default crisis](#) during a touchy meeting. They planned to meet tomorrow...**BUT THAT MEETING HAS BEEN POSTPONED TO NEXT WEEK.**

To raise the debt ceiling, Biden needs support not only from House Republicans but also from some Senate Republicans and McConnell to secure the 60 votes necessary to overcome a filibuster in the Senate.

McConnell said that won't happen until Biden reaches an agreement with McCarthy.

Treasury Secretary Janet Yellen warned that the U.S. could breach the debt ceiling by June 1 — earlier than expected — if Congress doesn't act.

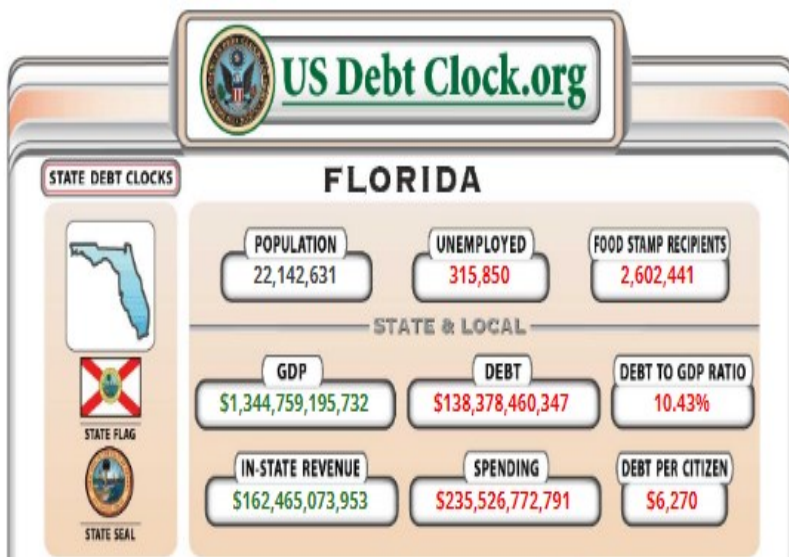
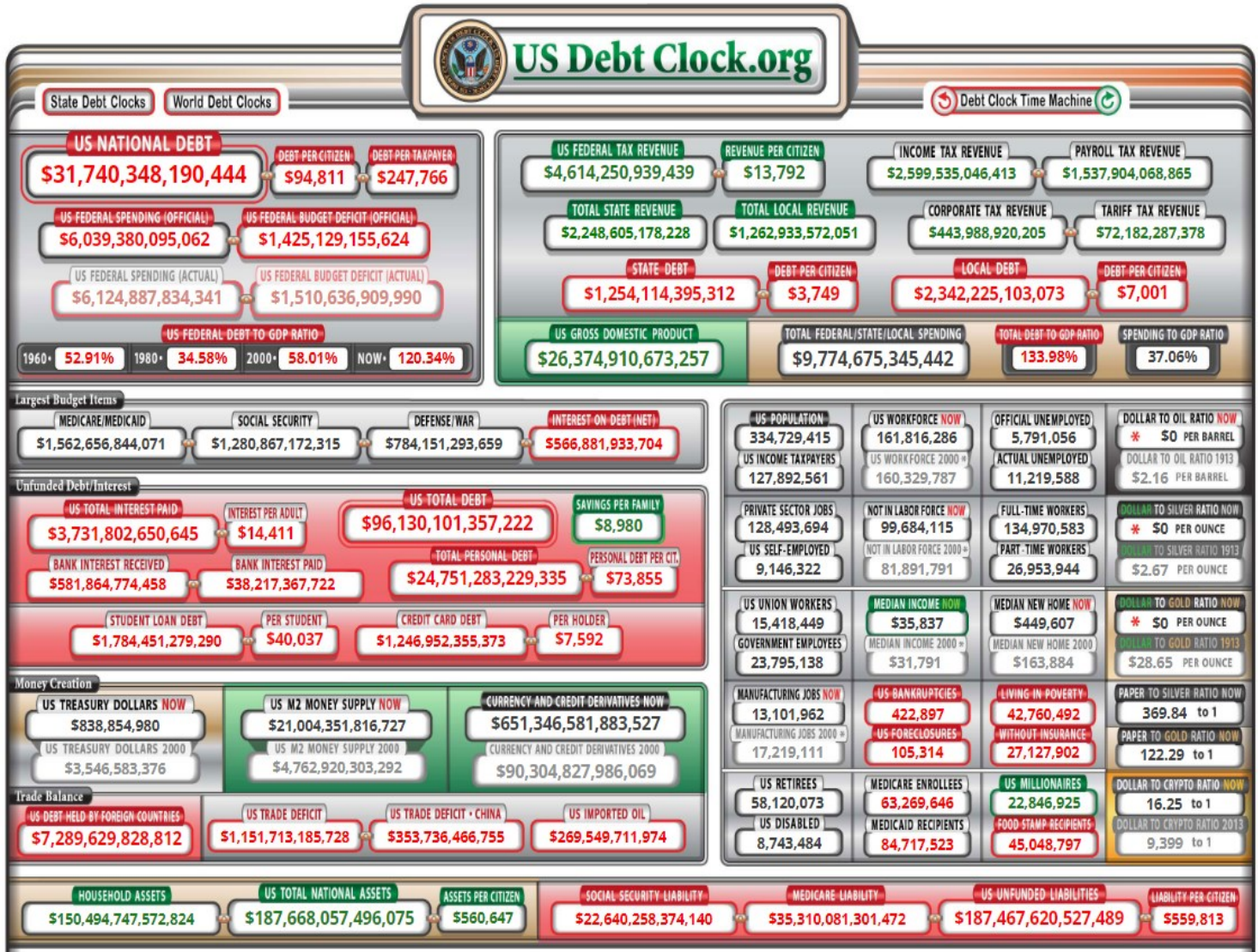
Unified Planning Work Program is a work plan and budget for the TPO. It lists all of planning and outreach activities the TPO will undertake

Official Florida House Districts

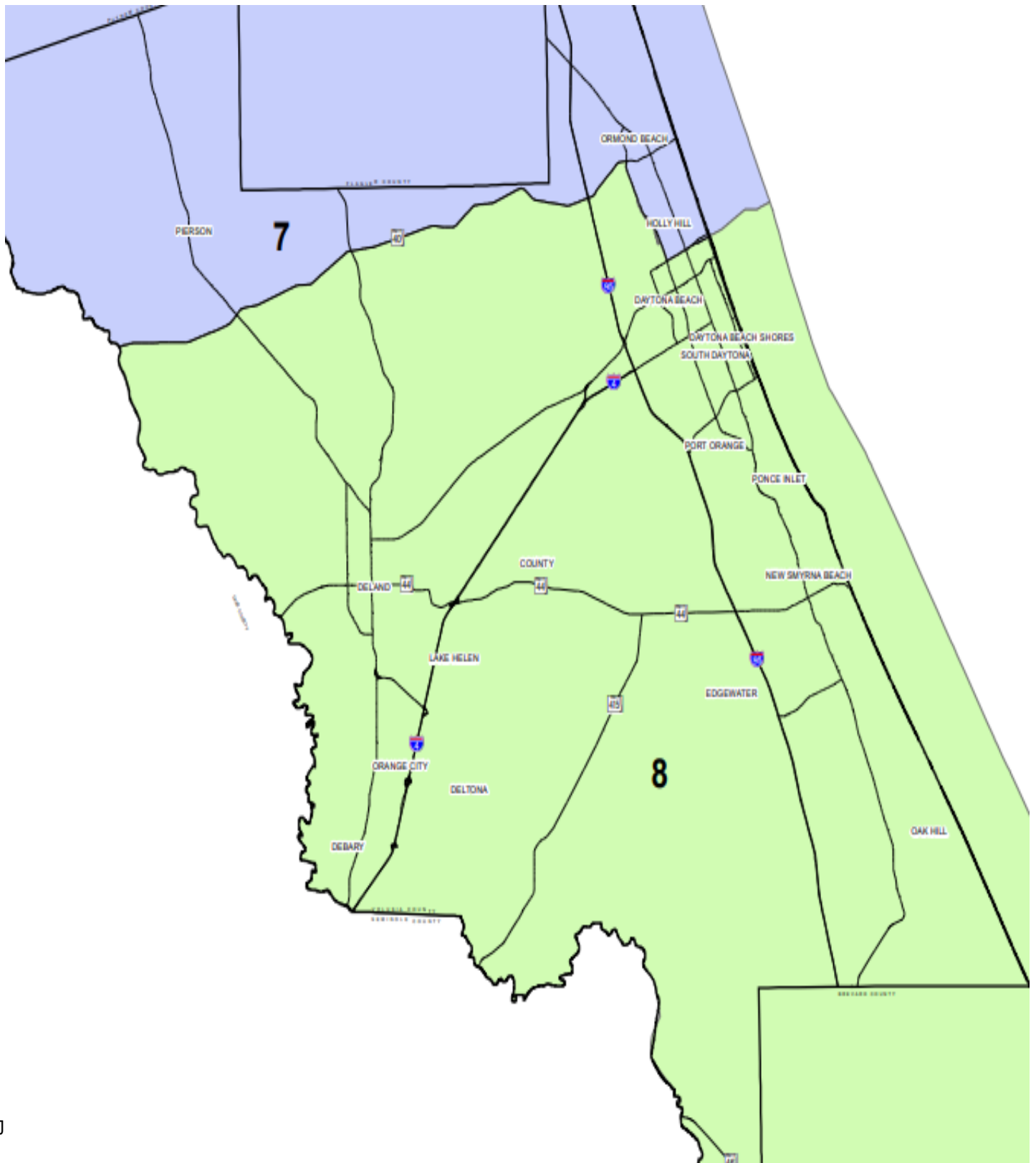

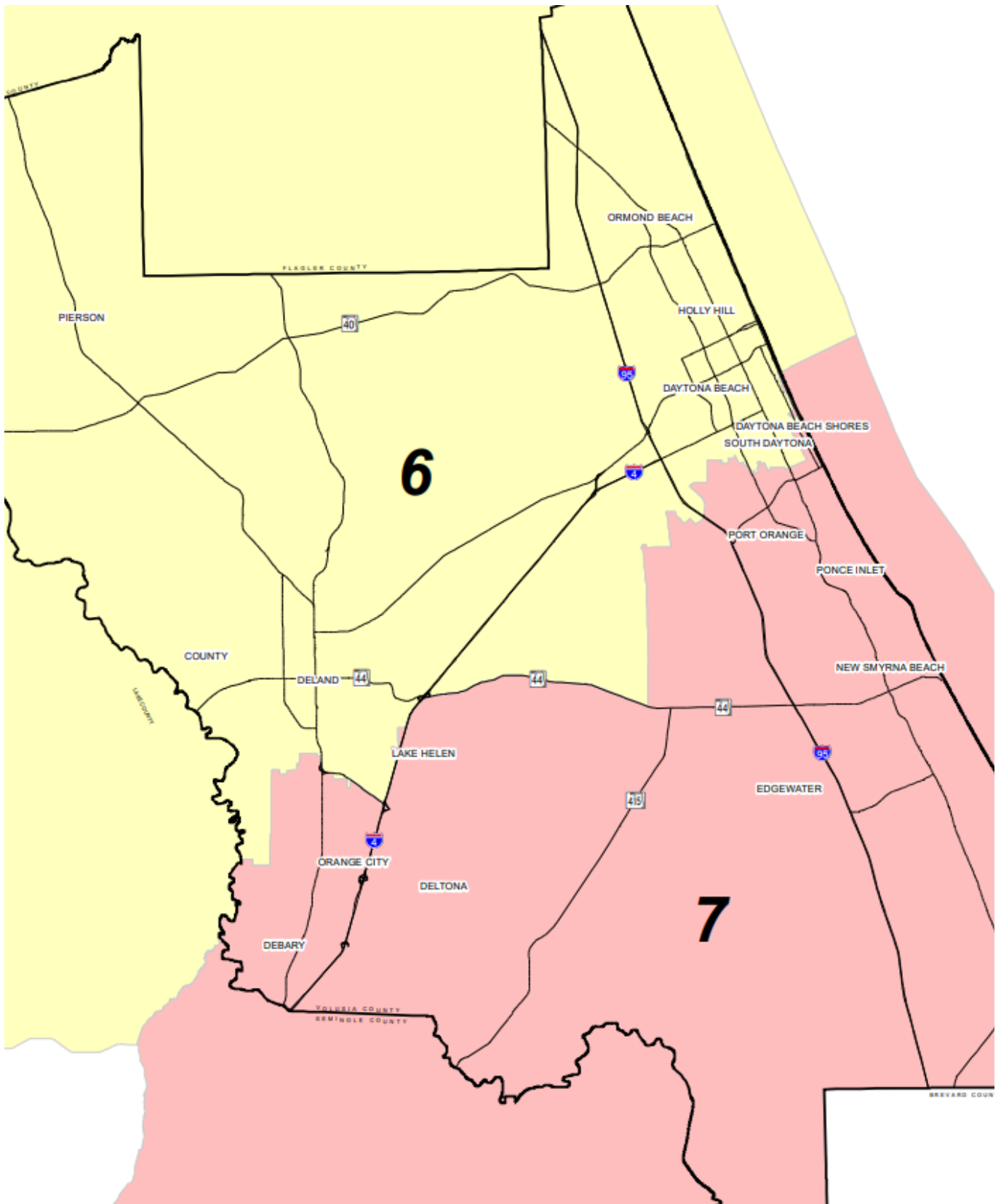
Florida Senate Districts 7 and 8

Volusia area

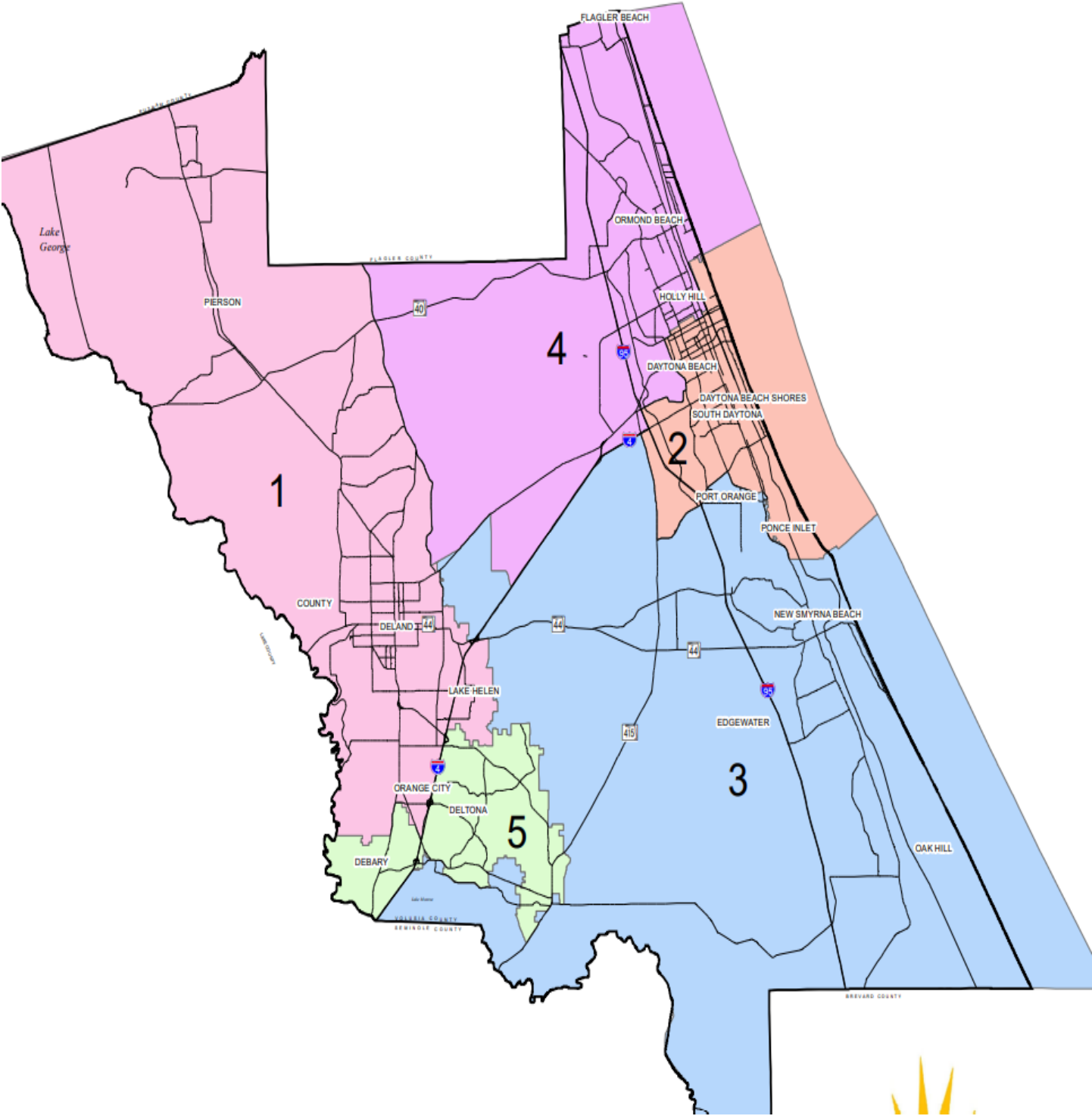

Congressional Districts 6 and 7

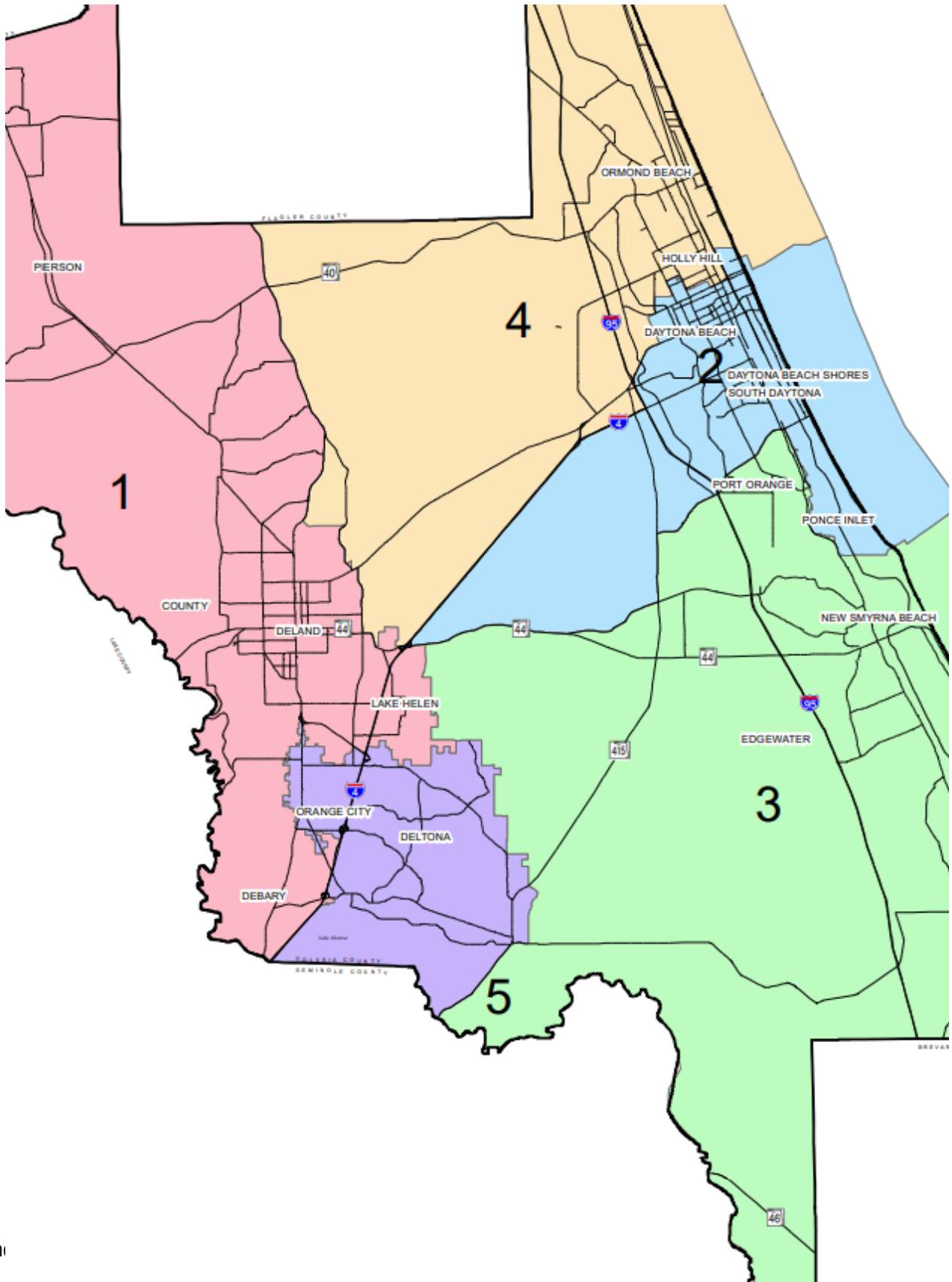


Volusia County Council Districts
